AGITATION PROGRAMS - UFRRBU GIVES CALL OF TWO DAYS STRIKE ON 15-16 MARCH, 2021

Dear friends,

On the issue of undue delay in implementation of 11th Bipartite wage settlement / 8th Joint Note in RRB sector and the retrograde proposals of the Government to privatise Public Sector Banks, the virtual meeting of all constituents of the UFRRBU, held on 17th February, 2021 evening, after detailed discussion, unanimously decided to observe :

- **Demonstration at HO / RO of all RRBs on 12th March 2021**
(time may be decided by base units as per their suitability).

- **Two days Strike on 15th and 16th March, 2021 –**

- **Opposing Privatisation of Public Sector Banks**
- **And Demanding -**
 1. Extension full benefits of 11th Bipartite Settlement / 8th Joint Note for wage revision in RRBs in terms of the NIT Award / orders of the Hon'ble Supreme Court.
 2. Settlement of all other pending demands of - **Amendment of Promotion Policy**, proper **Man Power policy** and **adequate recruitment** in all vacant posts, **Computer Increment**, **Compassionate Appointment Scheme** with retrospective date, **Daily Waged workers issues**, **Pension matters** etc.

Dear friends,

In the Budget speech Union Finance Minister has proposed to privatize the Public Sector Banks which have sponsored the RRBs. Further, RRBs Act has already been amended earlier to decrease the Government stake in RRBs from the present level of 50%. This action is against National Economy, interest of common people of the country and also against workforce of the Banks who have been rendering their relentless services to make host of national programmes successful.

Extend full benefits of 11th Bipartite Settlement in RRBs

In terms of the NIT Award, pay parity has been implemented for RRB staff on par with corresponding cadres of Sponsor Bank staff. Subsequently, Hon'ble Apex Court passed orders to confirm the same. But, violating the NIT Award and Apex Court orders, Bipartite Settlements have been implemented in RRBs in distorted manner earlier. Hence, we demand immediate

implementation of 11th Bipartite Settlement / 8th Joint Note for officers wage revision in RRBs in totality and without any deviations.

Settlement of long pending issues

Parity of Staff Service Regulations with those of Sponsor Banks, amendment of **Promotion policy** and Man Power planning for **adequate Recruitment**, extension of **Computer increment**, effecting **Compassionate Appointment** wef 05.08.2014 as per prevailing scheme in Commercial Banks, settlement of left out **pension parity** issues, and **regularization of daily waged staff**, which have been lying pending before GOI, MOF, DFS for a long time.

Hence, we call upon the rank and file to make the agitation all success.
